## **Vice President for Awards and Recognition**

Thank you for your patience and understanding during the first year of submitting applications on-line. Thirty agents submitted 68 award entries. Fifty-six of those were NEAFCS awards, and 12 were Kentucky only awards.

Nine NEAFCS categories did not have entries (Greenwood Frysinger, Educator of Year, Past President's New Professional, Research, Child Care, Educational Curriculum, Internet Technology, Housing Outreach, Clean and Healthy Families and Communities). The KEAFCS Outstanding Agent and Pride of Kentucky Grant did not have any applications, either. Now is a good time to be thinking about awards you can enter in those categories next year!

Forty-three entries were submitted to NEAFCS as state winners, and four KEAFCS categories had first place winners. Everyone has been notified, however, since our KEAFCS Awards and Recognition Banquet is not until December, please wait until that time to publicize your accomplishments.

Thank you to everyone from across the state who assisted with judging. The feedback from the judges was used to correct errors in the electronic copies before they were sent on to NEAFCS. At the national level, the awards will only be judged electronically. The most common mistake was leaving off 5x7 action photo, and other mistakes included narratives, supplemental pages, or letters of support that were not uploaded due to file space.

Remember when you submit awards to check the NEAFCS Awards manual for the guidelines and follow those. It makes it easier to read if you write your narrative in an outline format, and include your name and award category on each page. I cannot stress enough how important it is to get someone to

proofread for grammatical errors, misspelled words, and incomplete sentences. Sometimes, that is the determining factor for not winning.

At the KEAFCS board meeting, the board voted for the Kentucky only awards be submitted electronically next year. I hope that will make applying for awards much easier, and I hope more people will apply. For the Awards Banquet at the NEAFCS meeting, the board voted to purchase a corsage for the person submitting the award application, and not for all team members.

I learned a lot this year about the on-line awards process, and, although I will not be the VP for Awards and Recognition next year, I will be happy to help any way I can.

In April I traveled with Edith Lovett from our association to the Public Issues Leadership Development (PILD) Conference in Alexandria, Virginia. The theme for the 2015 PILD Conference was "Imagining Extension – Eyes on the Future." The entire conference was informative and a great time to build networks across the extension professional associations.

There were many conference hi-lights. The NIFA National Program Leaders met with the FCS delegates from across the United States to provide updates on national FCS programs and the impact these extension programs are making across our country. In another session, we learned about our two roles—educating and advocating—when we send information to our legislators or visit with them.

Then we spent the final day of the conference visiting with our legislators on Capitol Hill. Our Kentucky delegation broke into several groups so that we could visit the offices of all our representatives and senators. The groups I was in visited Representatives Guthrie, Barr and Massie plus Senator McConnell's office. We actually got to visit with two of the representatives and the office staff of the others. It was great to see hometown newspapers lying on the coffee tables in the reception areas of the offices. The office staffers and the representatives had personal experience with or knowledge of the extension service in their areas of the state. Keep up the good work of sending short updates to your national and state representatives and senators!!! Do invite them and their staffers to special extension events in your county.

One gets such a sense of history in the Washington, D.C. area with all the Smithsonian museums, the Library of Congress and our established process of government. To add to the nation's history, we celebrated the 125<sup>th</sup> Anniversary of the Passage of the 2<sup>nd</sup> Morrill Act during the PILD Conference. During our visit to Capitol Hill, our delegation toured Senator Mitch McConnell's office that included the portico where Senator John F. Kennedy's dog used to roam up and down. Senator McConnell's office space was once occupied by Senator John F. Kennedy! Then to add to the history of our nation's capital, I can say that the Kentucky delegation was on Capitol Hill when the one-man flying helicopter illegally landed on the capitol lawn! As in any news making event, there were police, emergency squads and roped off areas all over the place!

#### Spain

This 12 day travel experience took us through quaint little towns and also larger cities. Starting in Madrid, the streets were lined with people to see the parade celebrating the religious holiday of Corpus Christi. This holiday is a celebration of the body and the blood of Christ. It was a wonderful experience to share in this cultural event on our first day in Spain. While in Madrid, we visited many museums including the Prado which holds many masterpieces by Valazquez, Goya, Titan, Ruben and included some of Picasso's work. We also had the privilege of touring the Palacio Real where the royal family lives. At the end of our stay in Madrid, we stopped at El Rastro, one of the largest flea markets in Europe.

Just a short high-speed train ride took us from Madrid to the ancient city of Toledo. Overlooking the Tagus River, Toledo sits on a hill and it's small, cobblestone streets are very charming. There we toured a sword factory which captures the essence of historical metal working of the area. Toledo is known also for ceramics, gold, and a pastry confection called mazapan. We also toured the Cathedral of Toledo and El Greco Museum.

The next stop on the tour was Seville. There we visited the Cathedral and Giralda Bell Tower which is the world's largest Gothic cathedral which houses Columbus' tomb. After Seville we traveled to Granada and visited The Royal Chapel, a gothic chapel which houses the tomb of Kind Ferdinand and Queen Isabella. While in Granada, we explored the Moorish Palace of Alhambra. It was a good thing we had a whole day to tour this location since it contained multiple palaces and lush gardens.


